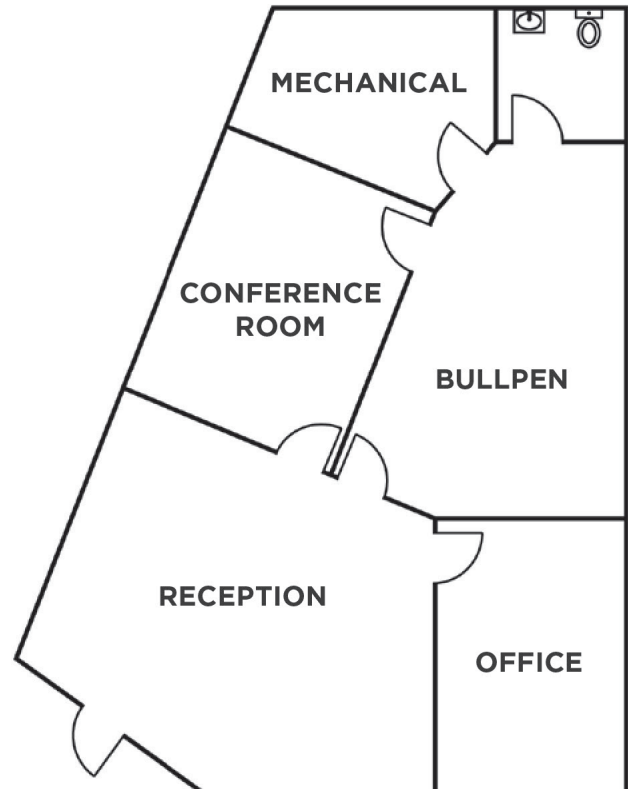

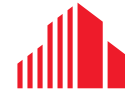
FLOOR PLAN



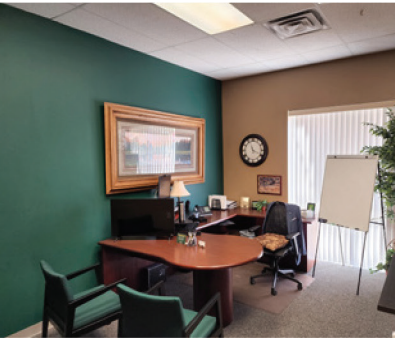
