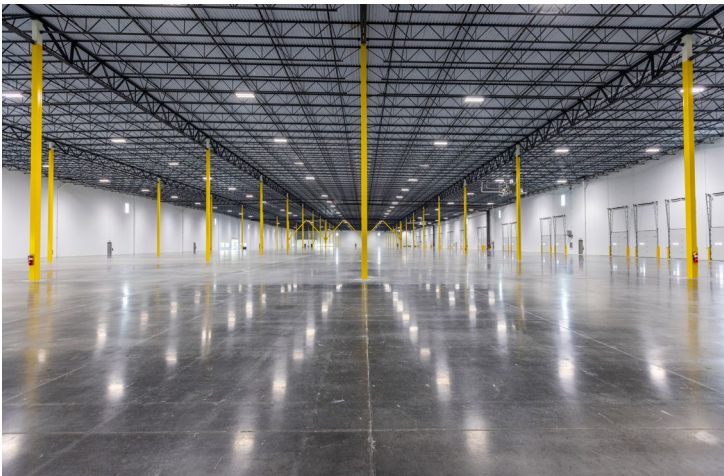
BUILDING PLAN
