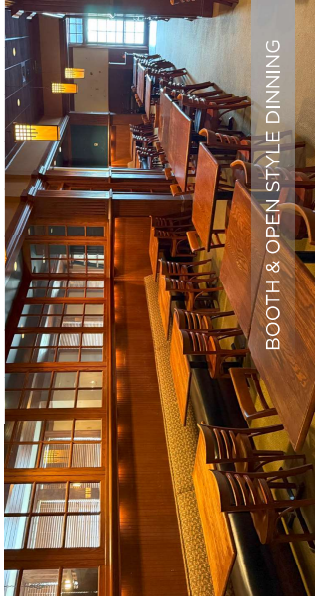
PROPERTY SITE PLAN



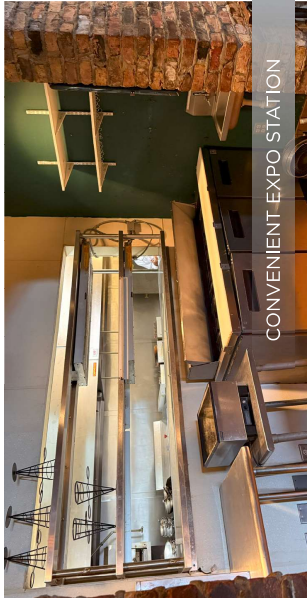
RESTAURANT FLOOR PLAN - 6,136 SF

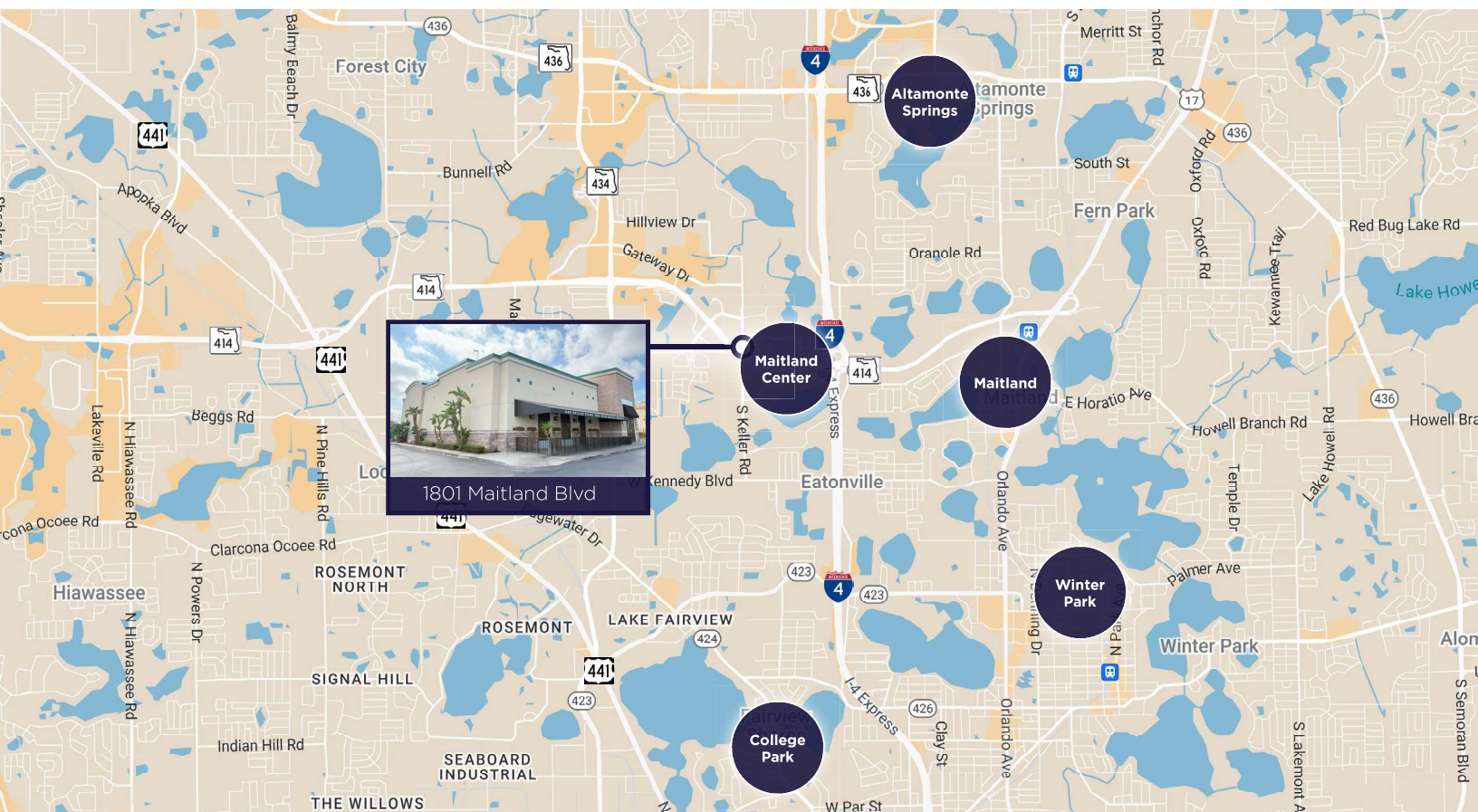
