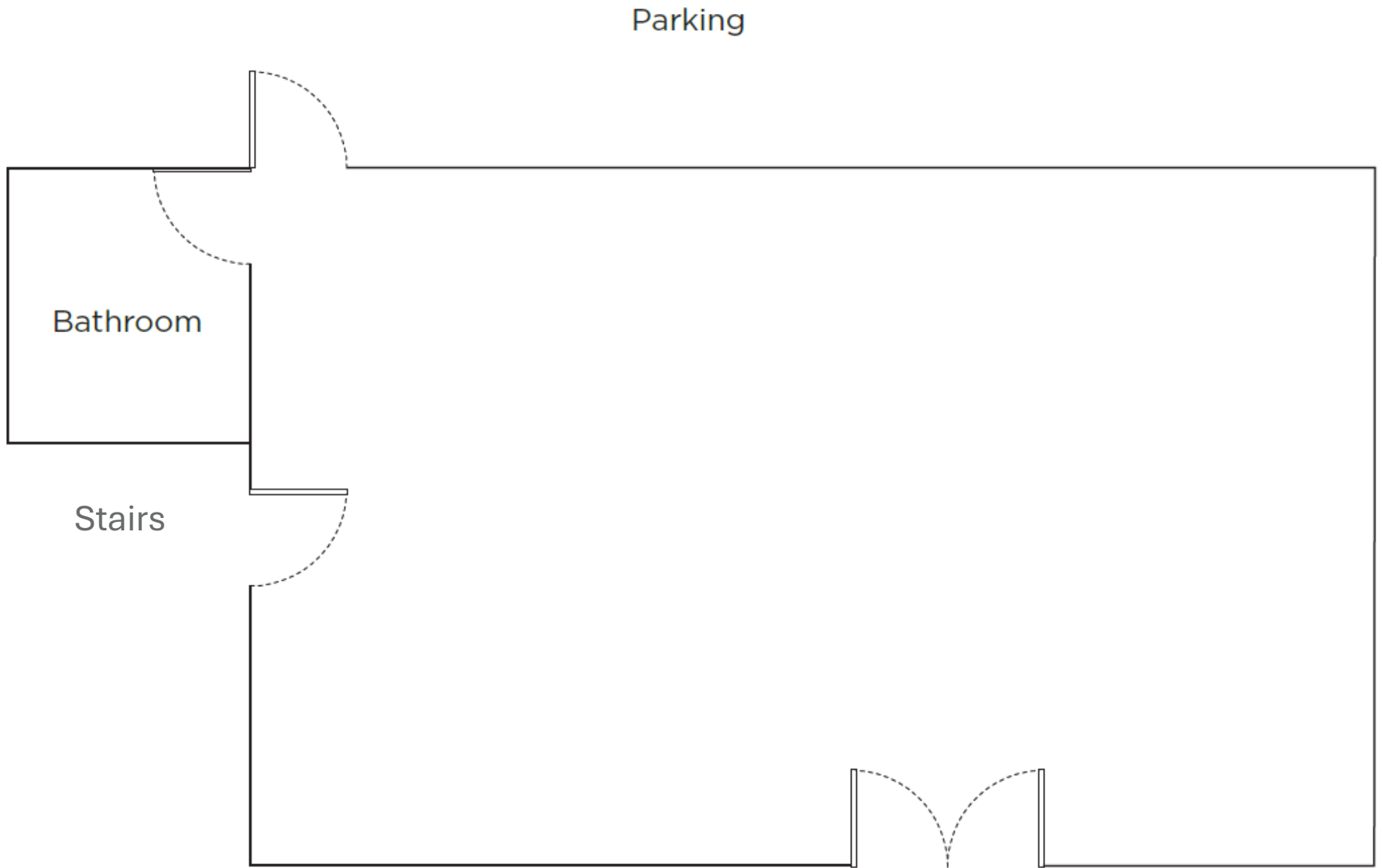

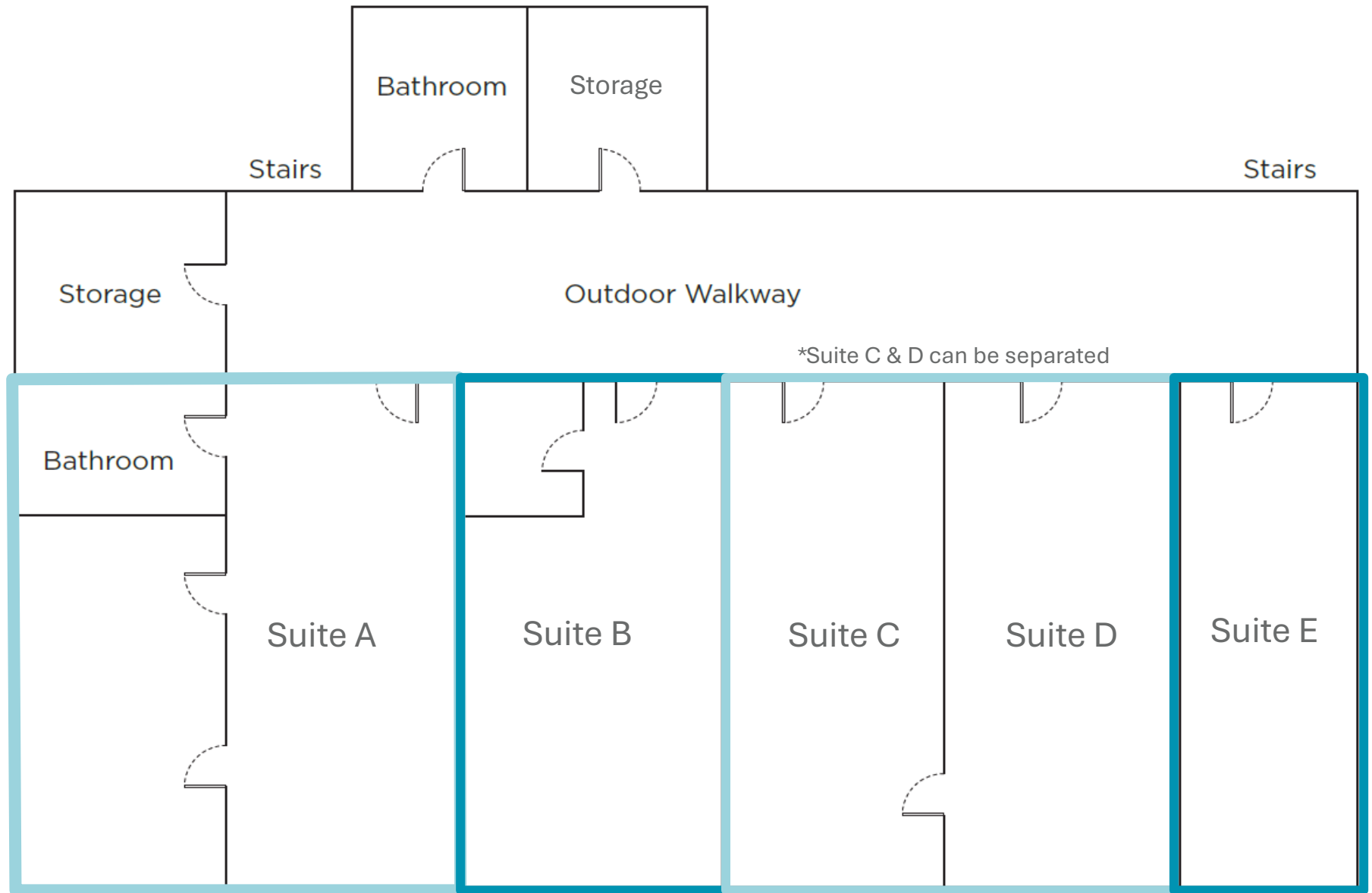

FLOOR PLAN



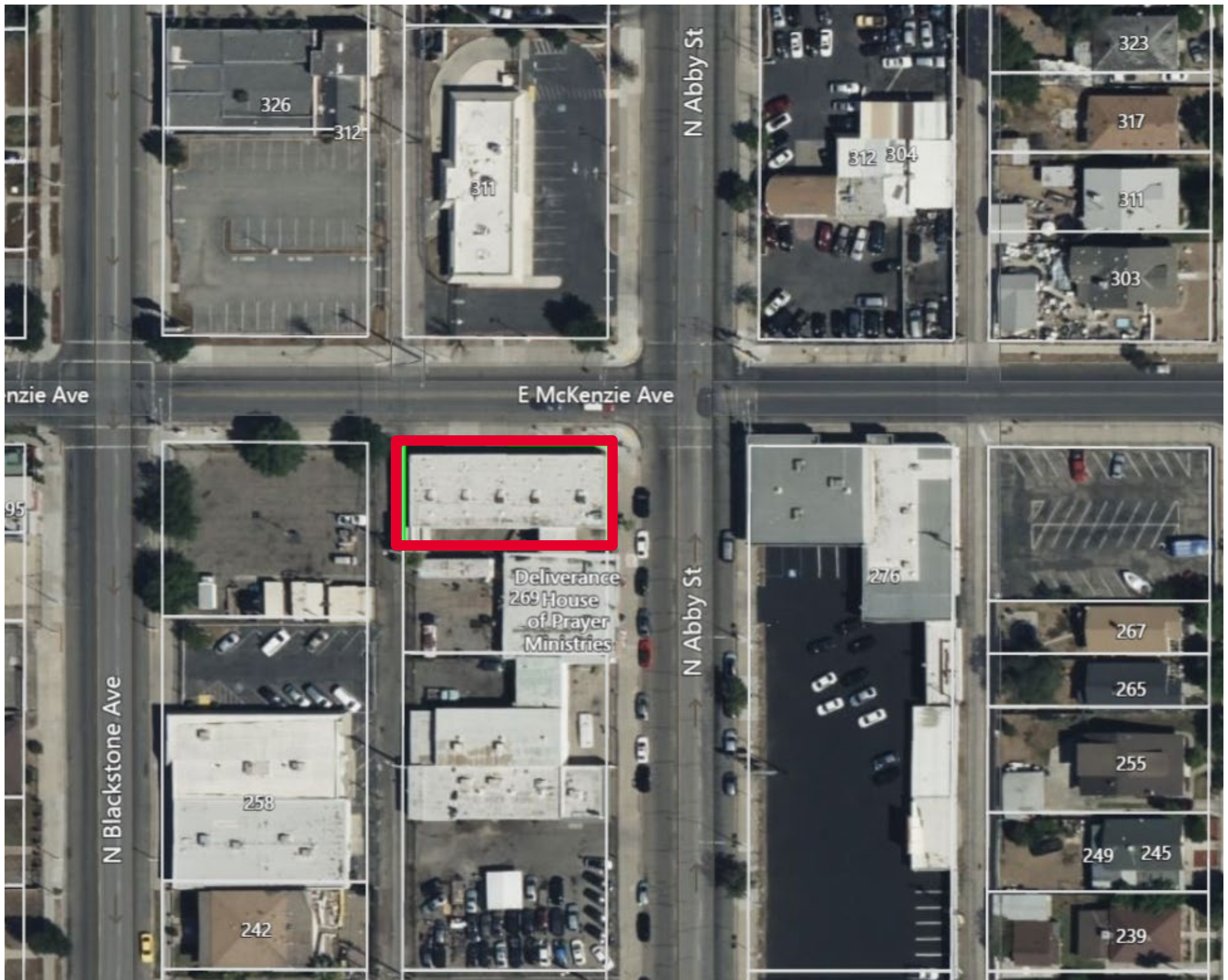

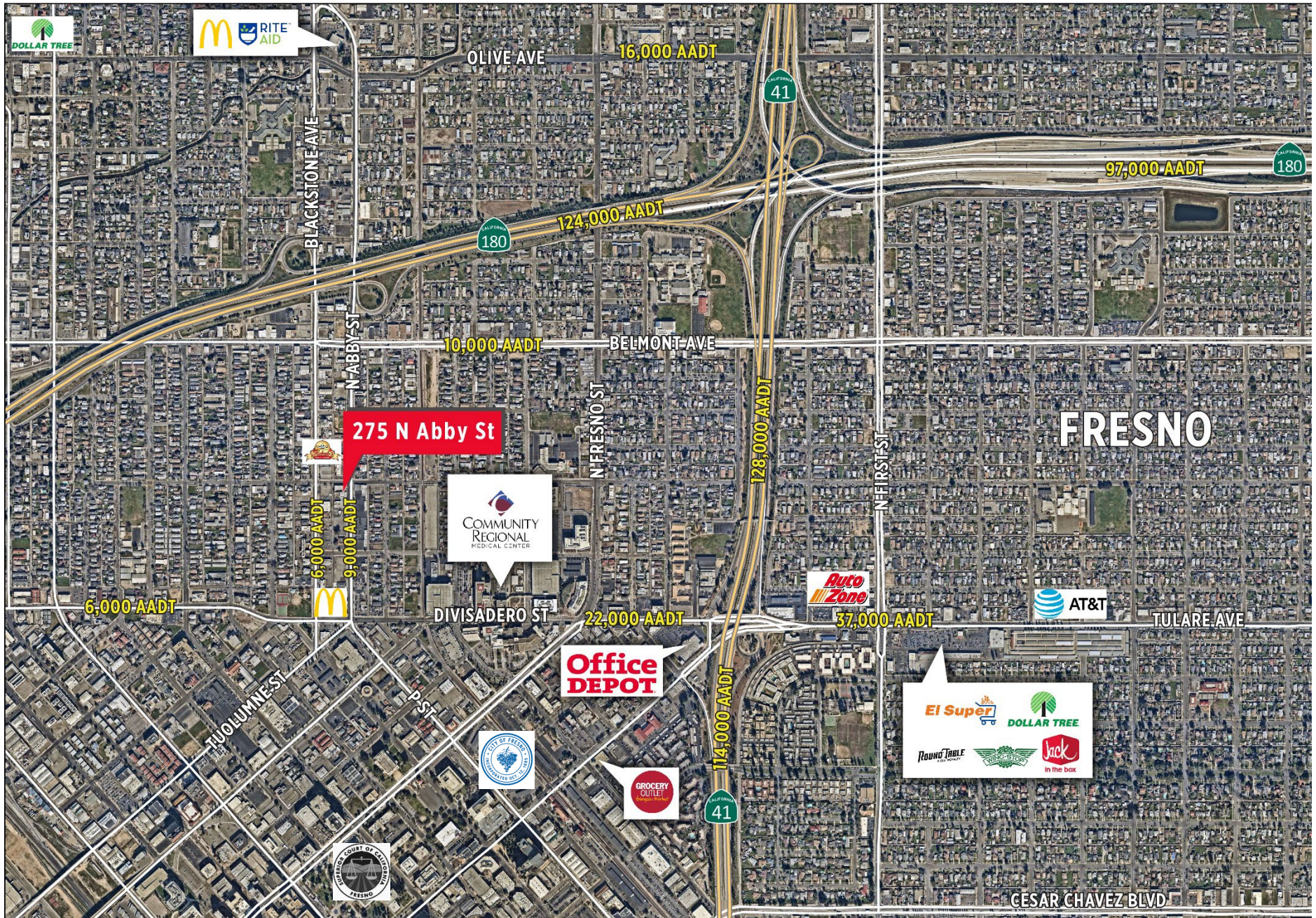

2nd Floor

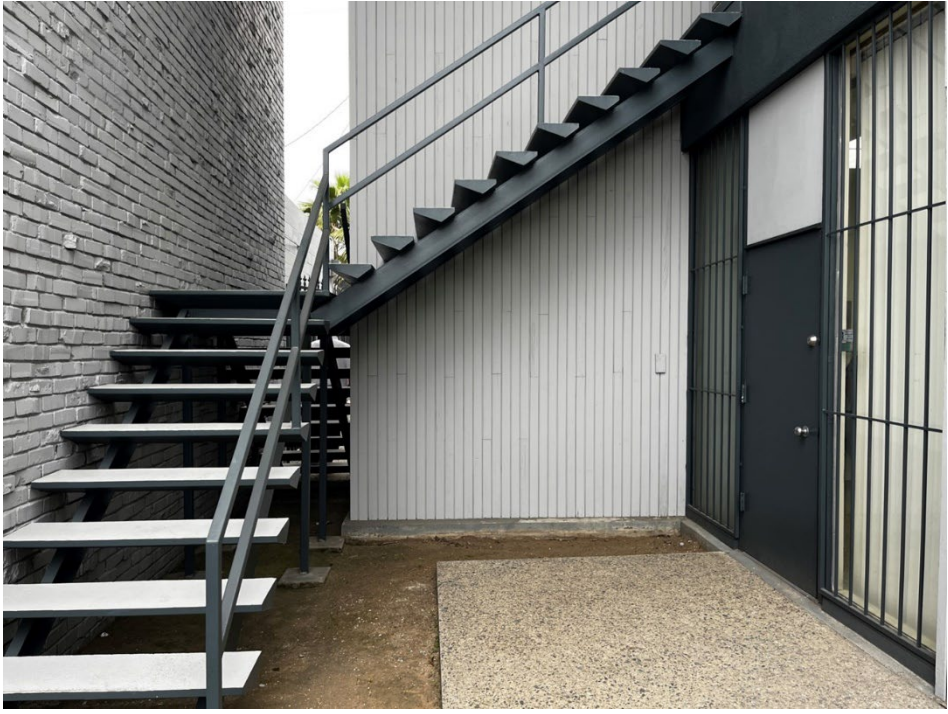
AERIAL - SITE PLAN
