

The Property

The Property is located on the southeast corner of Hurontario Street and King Street. The Site is 61,936 sf in size and is vacant and unimproved. The Site has over 180 feet of frontage along Hurontario Street and 165 feet along King Street.



The Location

Situated along a key stretch of Highway 10, just north of Brampton, in a semi-rural area that blends light industry, agriculture, and small-town amenities.
