

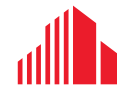

FLOOR PLAN



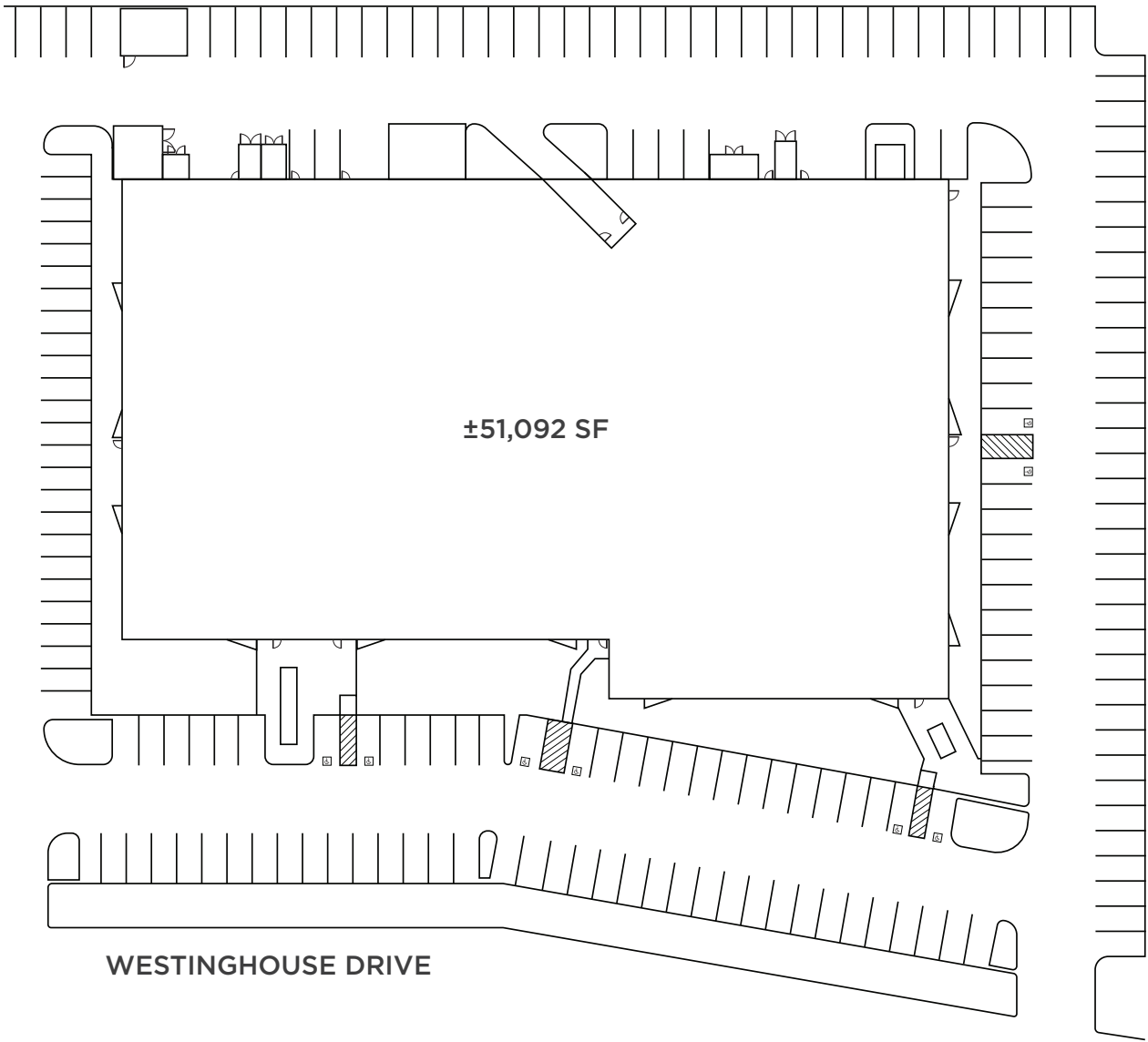
