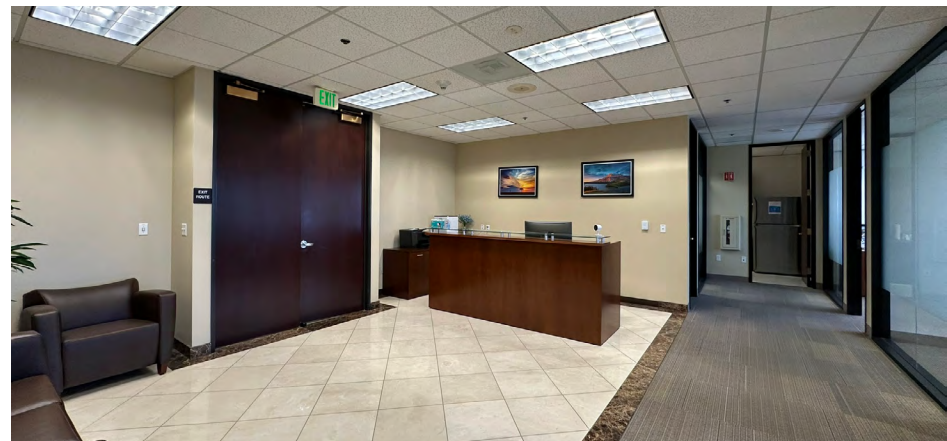

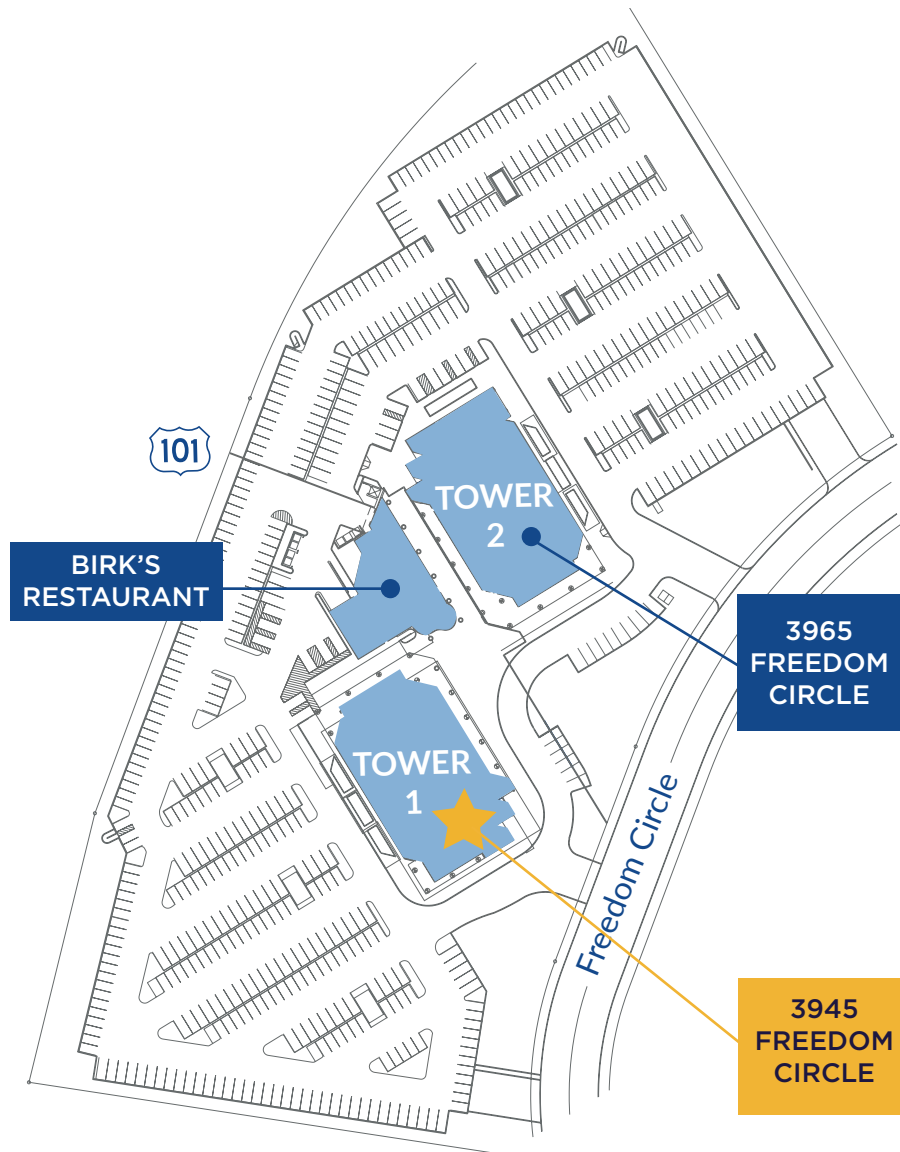

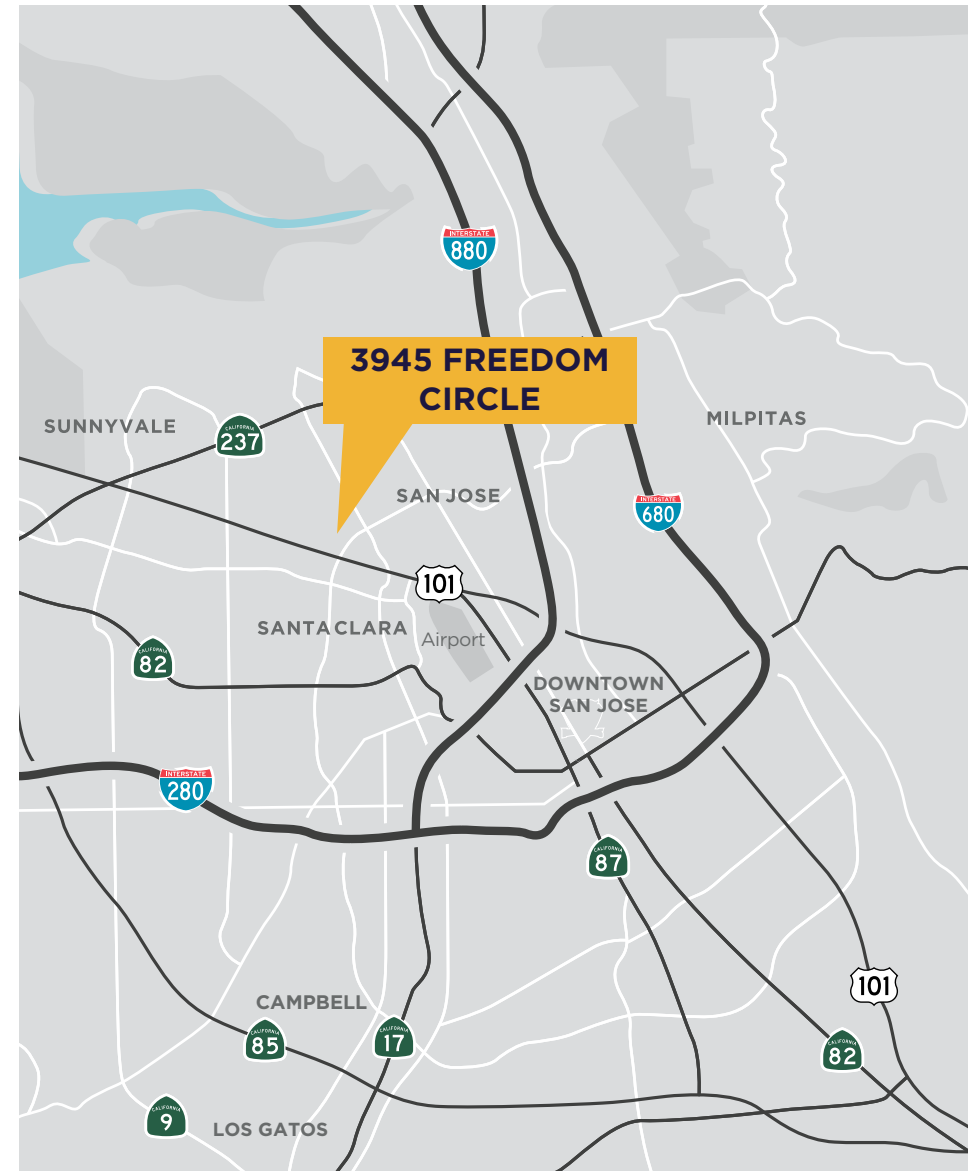
Santa Clara Towers
