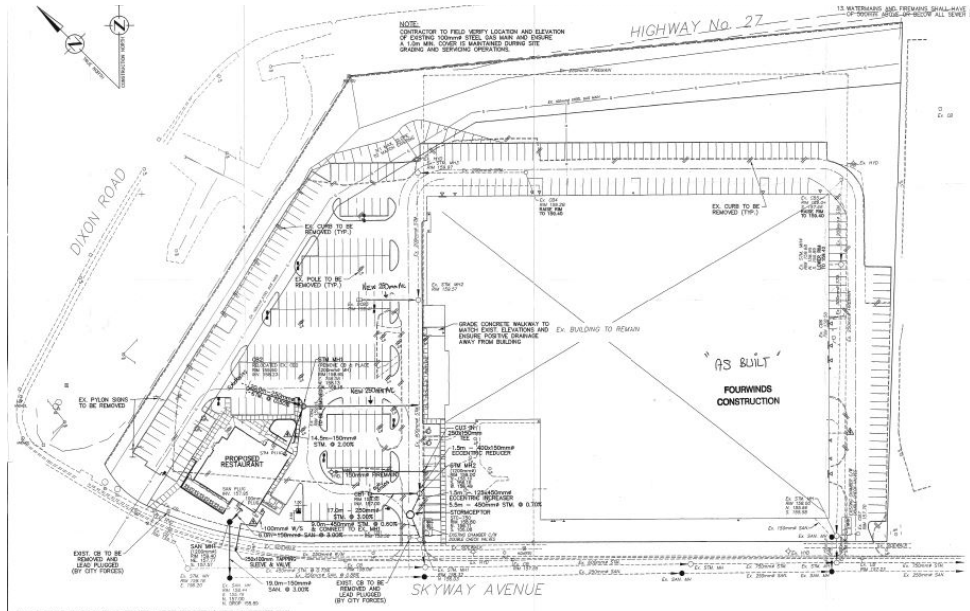

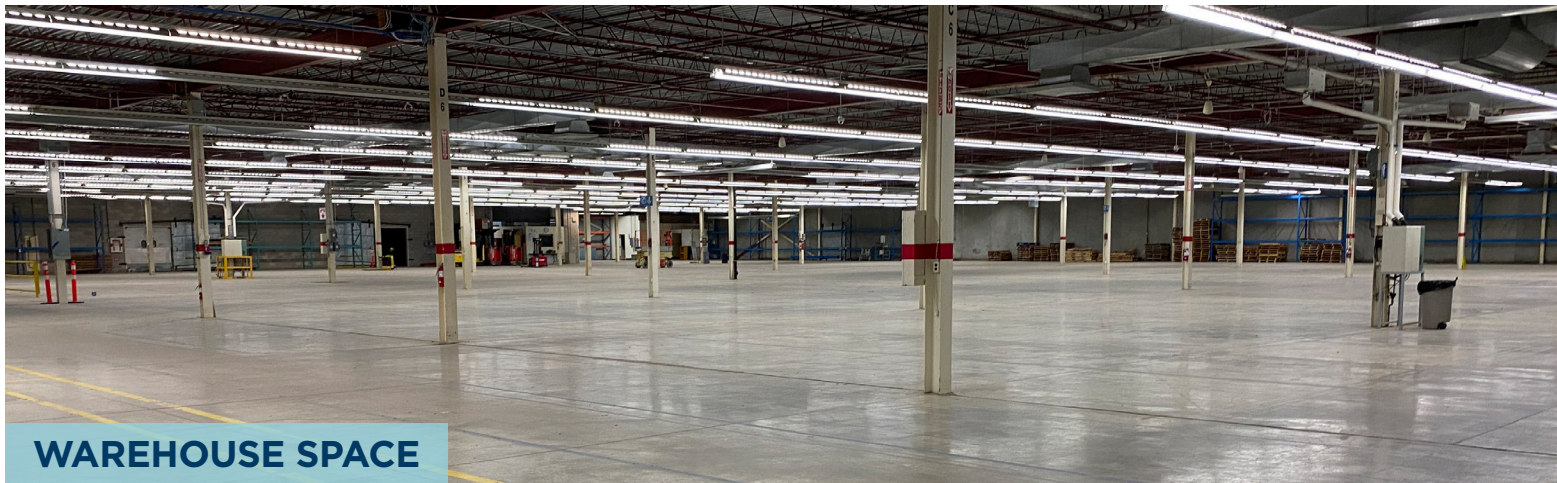
Site Plan



Floor Plan



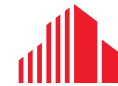

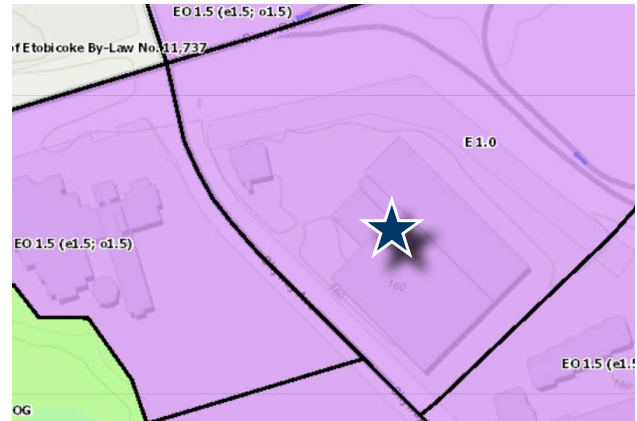

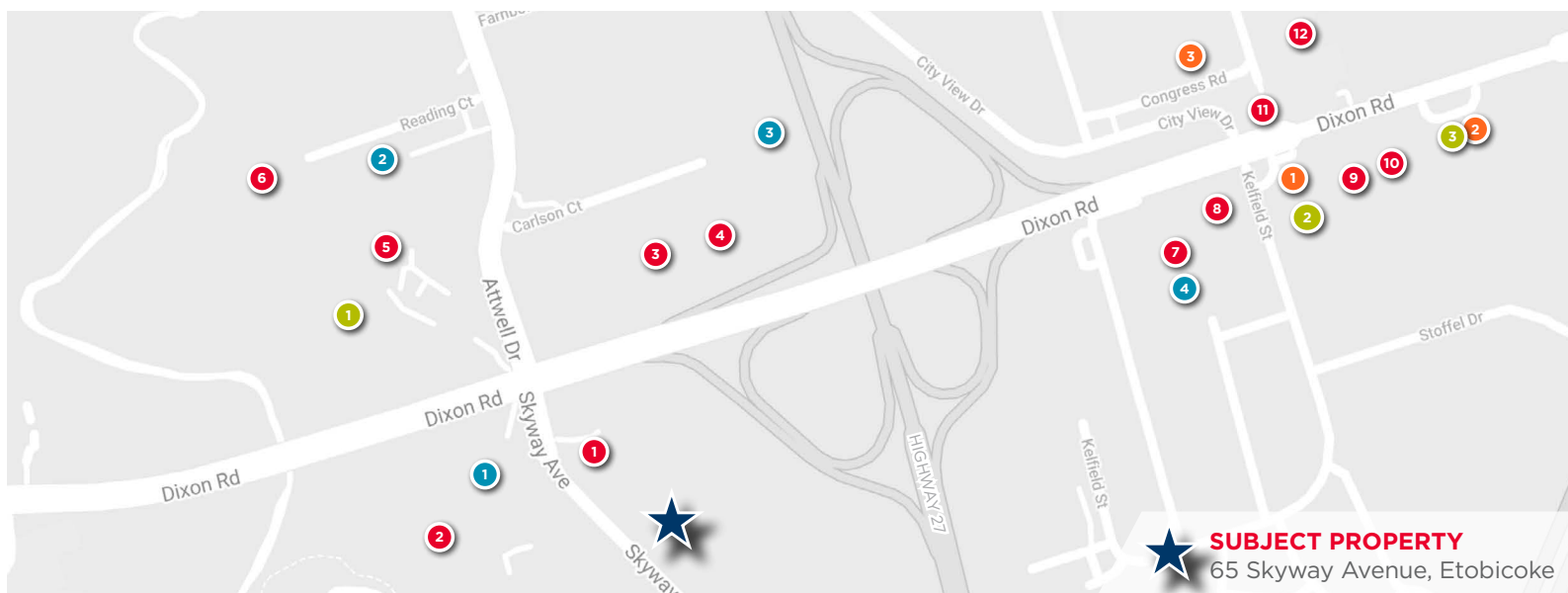
