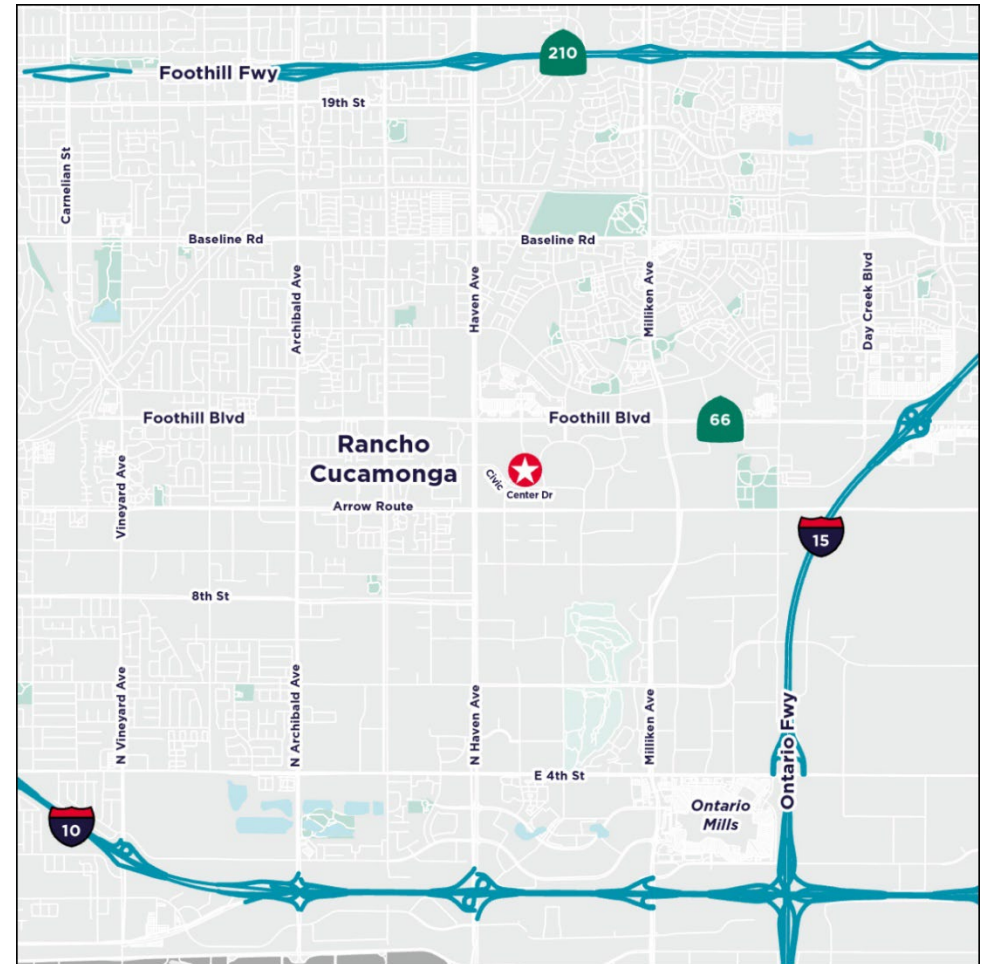

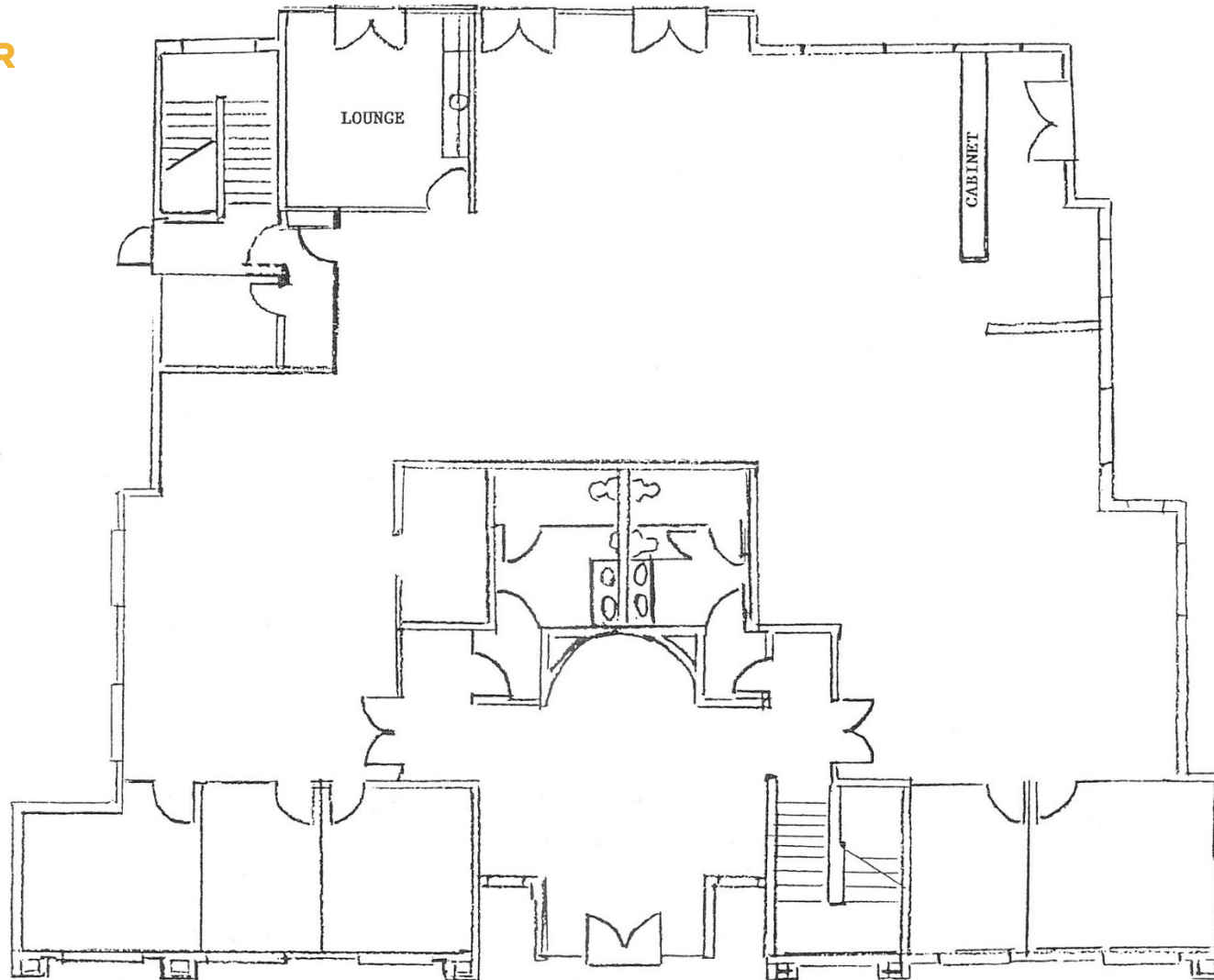


# FLOOR PLAN

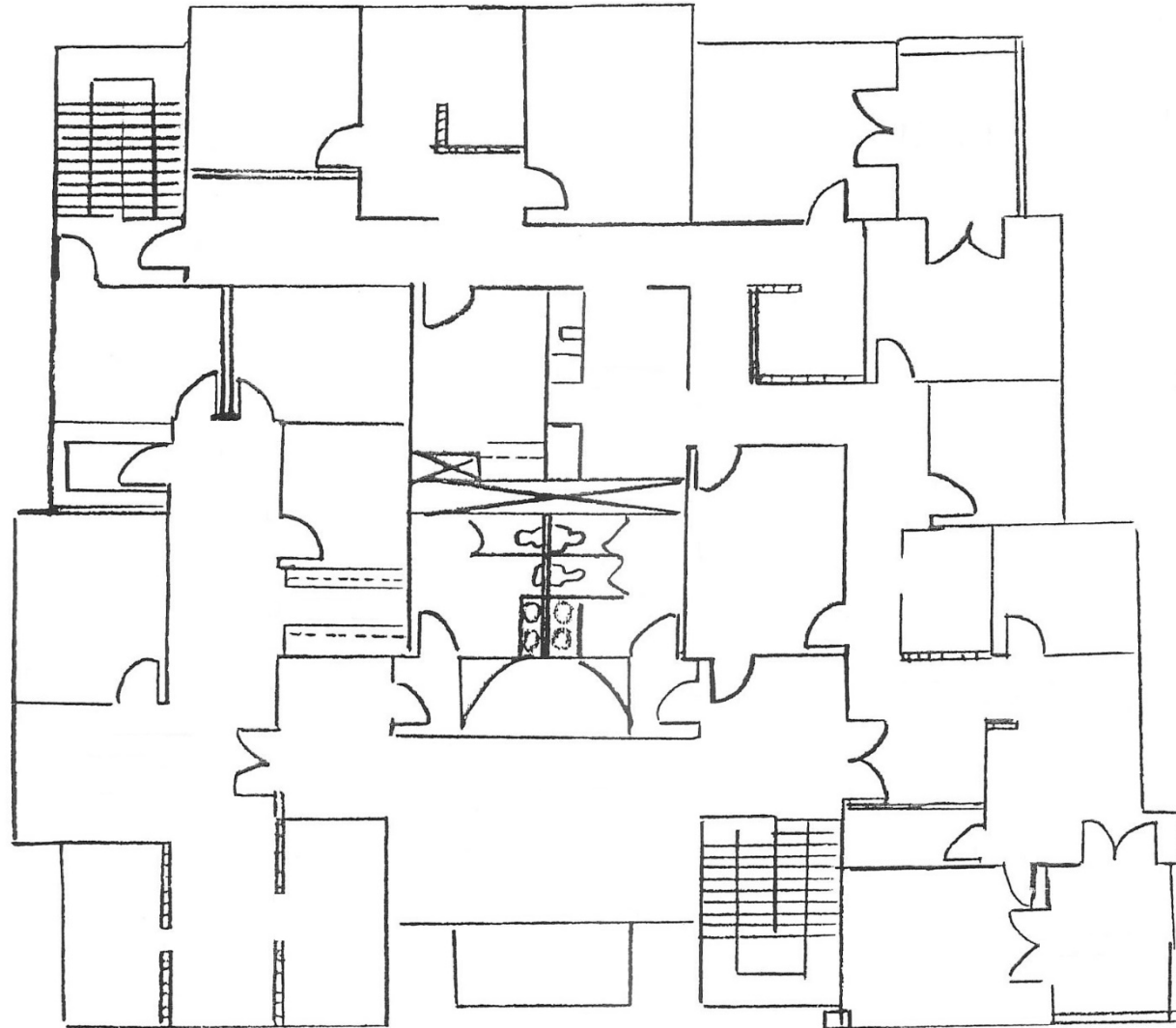
# FLOOR PLAN
