This is a stand-alone single story building with excellent on-site parking. The building boasts substantial electrical power @ 1200A 3ph 208V. This is rare for buildings of this size, especially buildings in CC zoning. A ±5,120 portion of the building is vacant, currently in shell condition. The balance of the building (±10,360 SF) is under lease to Santa Cruz Athletic Club. The lease expires on May 31, 2027. The Tenant has leased a larger location at 901 Soquel Avenue, next to Whole Foods Market, and will be opening the new location in 2025. Landlord will allow Tenant the opportunity to terminate its lease early providing Landlord locates an acceptable replacement tenant to occupy the entire building now.


