4.4.1 ROOFING MATERIALS

ROOF COVERINGS CONSISTED OF SINGLE-PLY THERMOPLASTIC MEMBRANE OVER LOW-SLOPE ROOF CONSTRUCTION.

EXTERIOR WALLS EXTENDED ABOVE THE ROOF PLANE AS PARAPETS AND WERE CAPPED WITH COPING. ROOF MATERIALS COVERED THE INBOARD SIDES OF THE PARAPETS. MATERIALS TERMINATED UNDER THE METAL COPING. FLASHING MATERIALS APPEARED TO BE SIMILAR TO THE ROOFING MEMBRANE.

SURVEY CONDITION AND ANALYSIS

THE ROOFING SYSTEMS APPEARED TO BE IN GOOD OVERALL CONDITION. ROUTINE MAINTENANCE IS ANTICIPATED DURING THE EVALUATION PERIOD. THE ROOF WAS REPORTEDLY INSTALLED IN 2021. BASED ON OUR OBSERVATIONS, THE REPORTED AGE APPEARED TO BE REASONABLE. A ROOF WARRANTY WAS PROVIDED FOR REVIEW AND THE ROOF IS UNDER WARRANTY UNTIL 2046.

ACCORDING TO THE SITE ESCORT, ROOF MAINTENANCE AND REPAIRS WERE CONDUCTED BY QUALITY TRUSTED CONSTRUCTION.

PARAPETS APPEARED TO BE IN GOOD OVERALL CONDITION, ROUTINE MAINTENANCE IS ANTICIPATED THROUGHOUT THE EVALUATION PERIOD.


