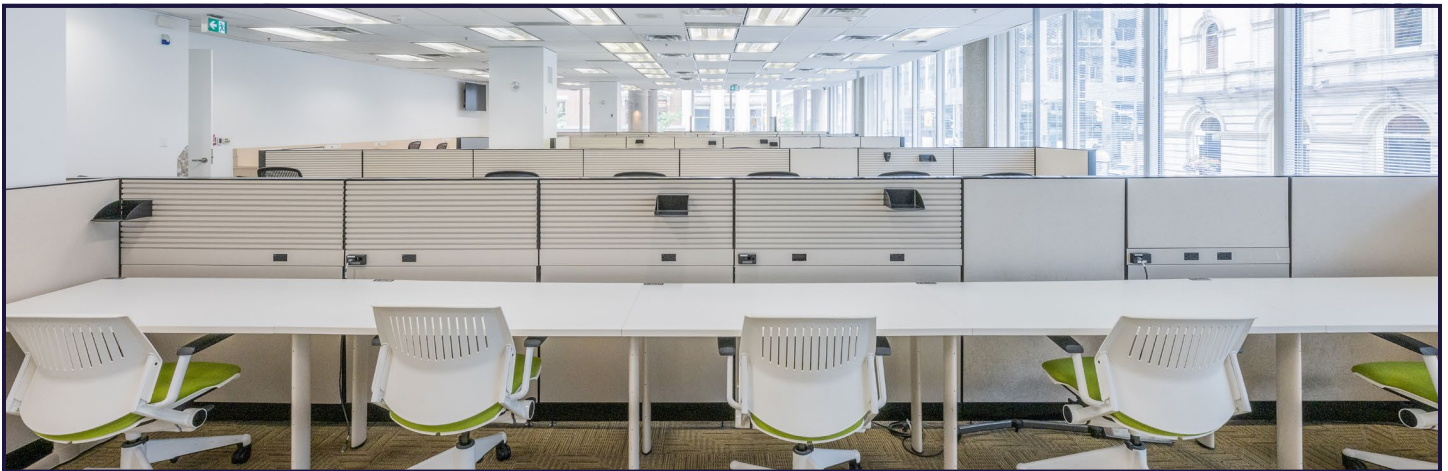

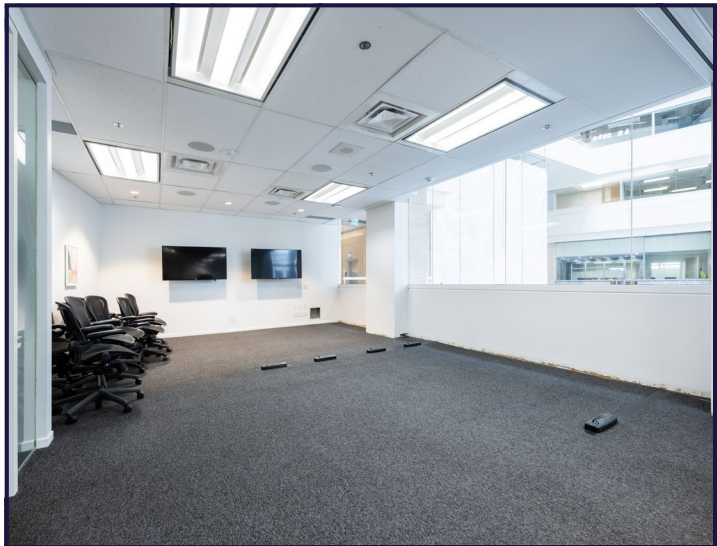

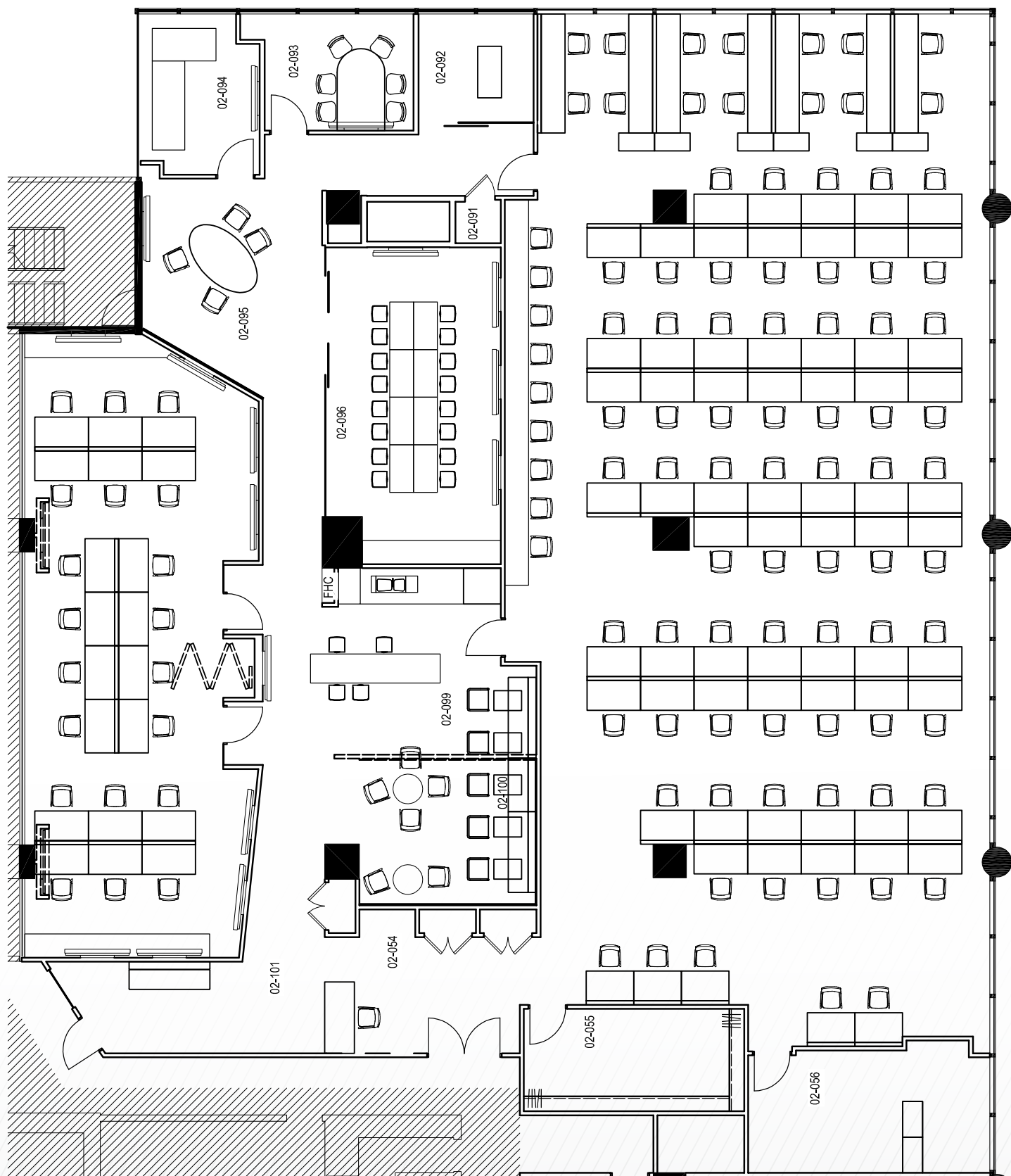

- Numerous on-site food service options including Ceci Bar, Sammarco, TheJoneses, Green Box, Café Landwer, and Tim Hortons



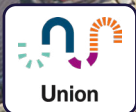




# FLOOR PLAN
