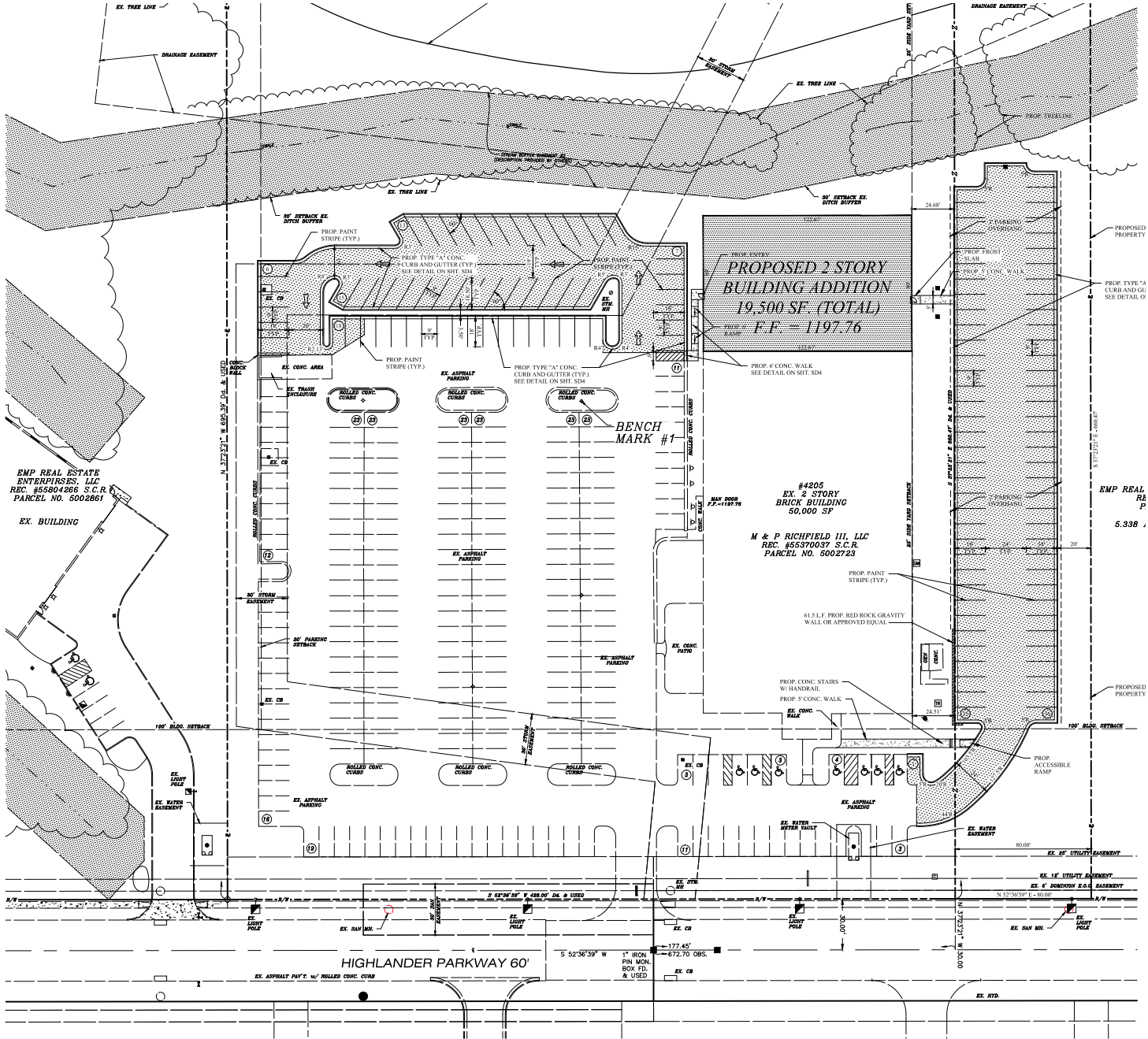

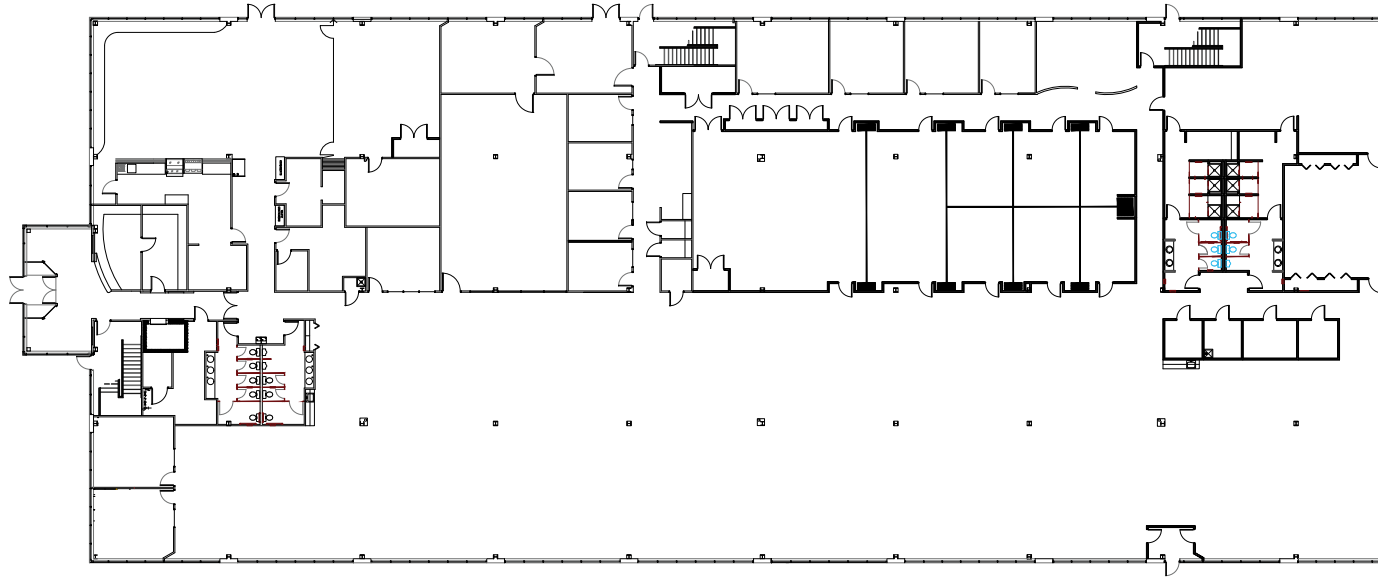

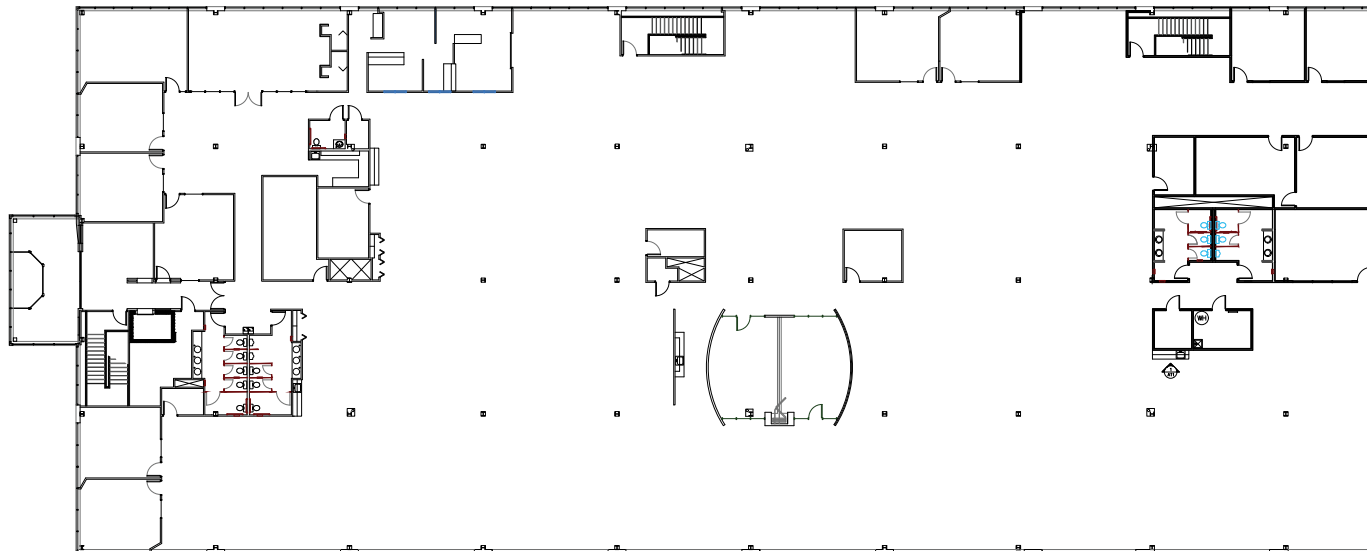
Site Plan
