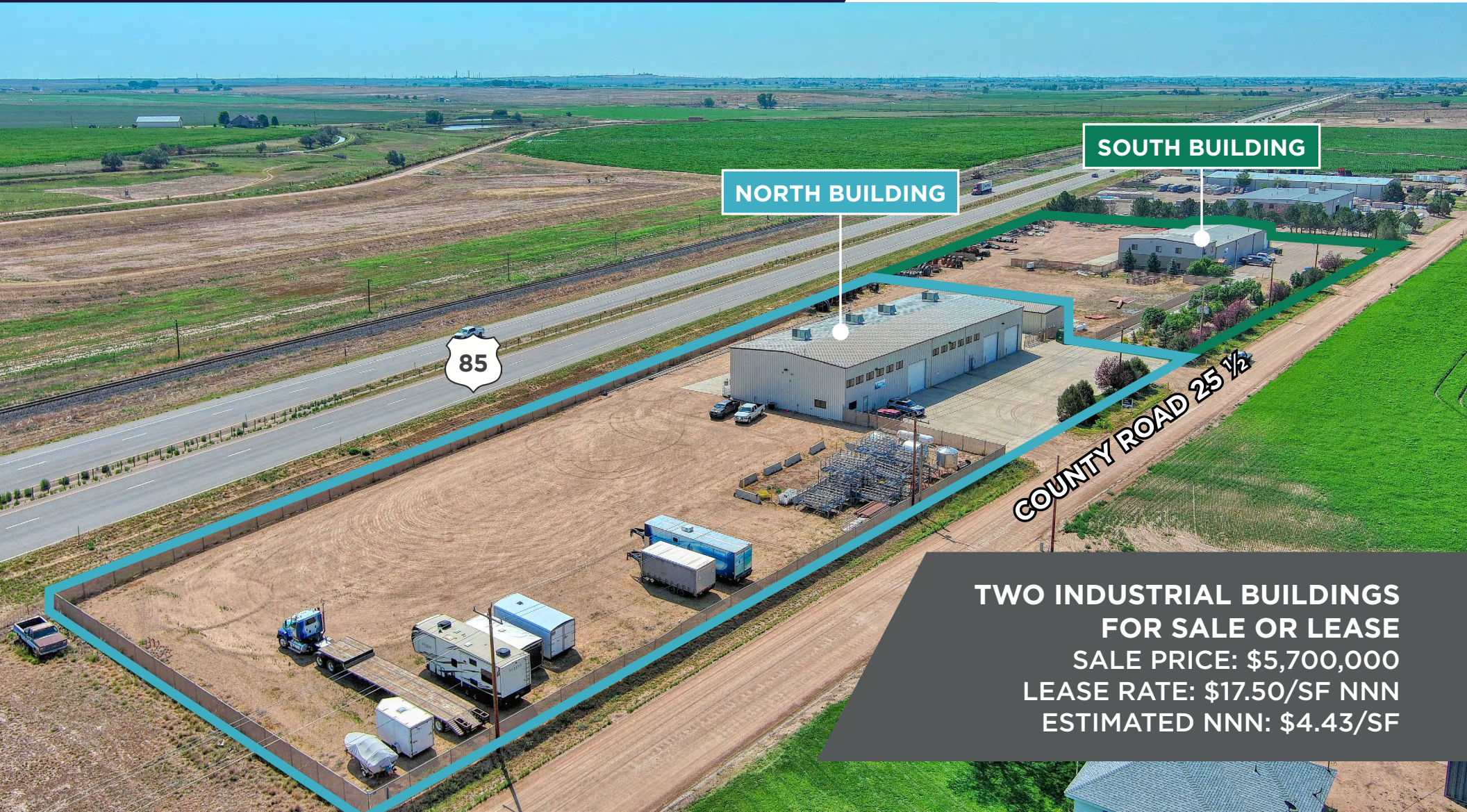

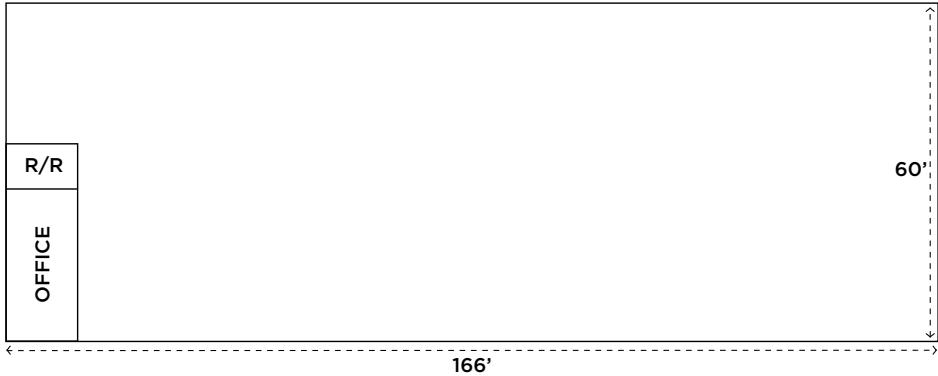

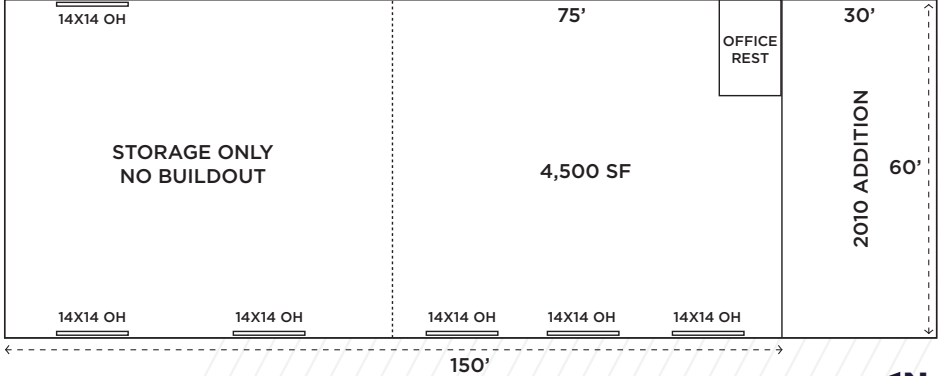


Building Floorplan

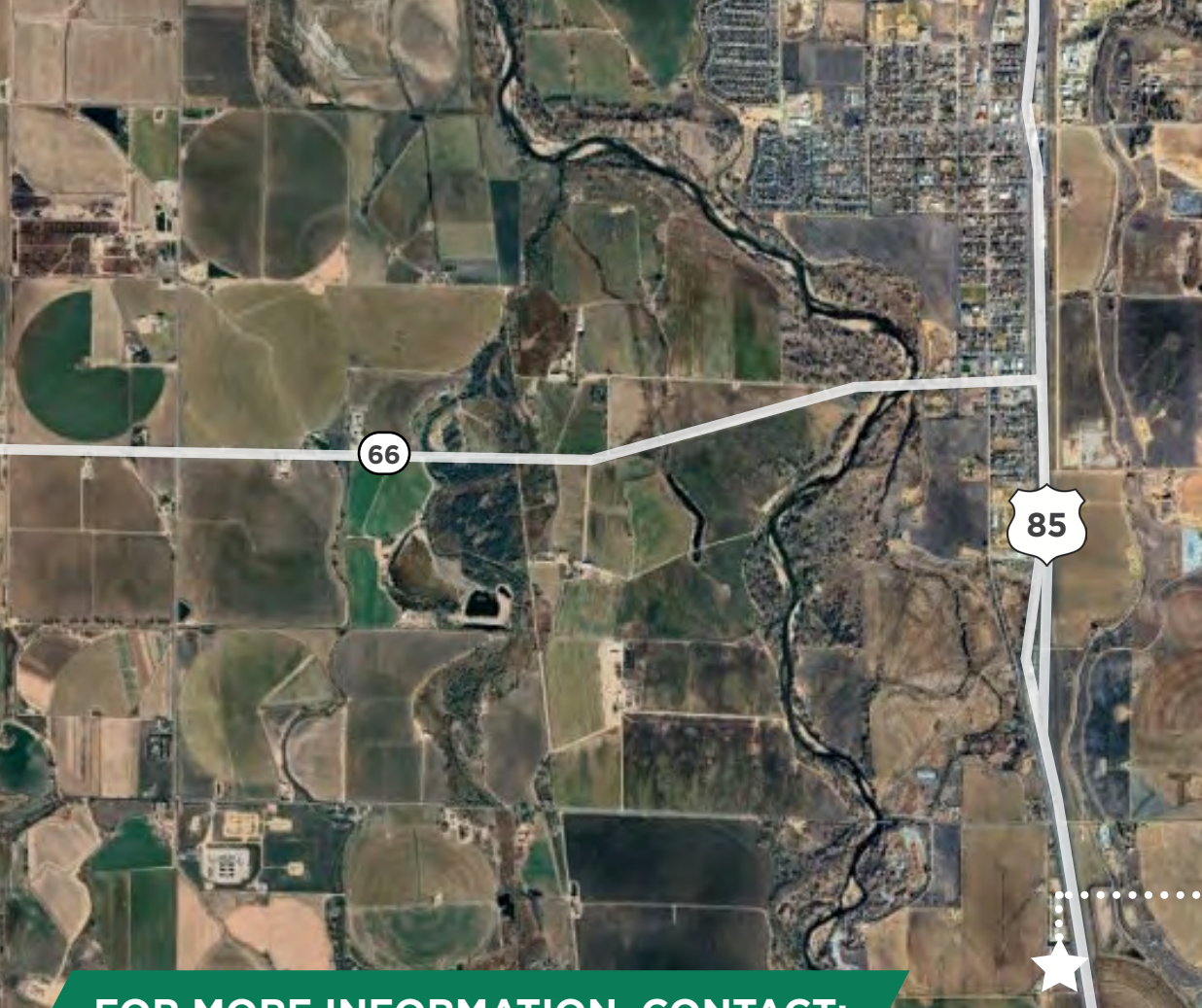
