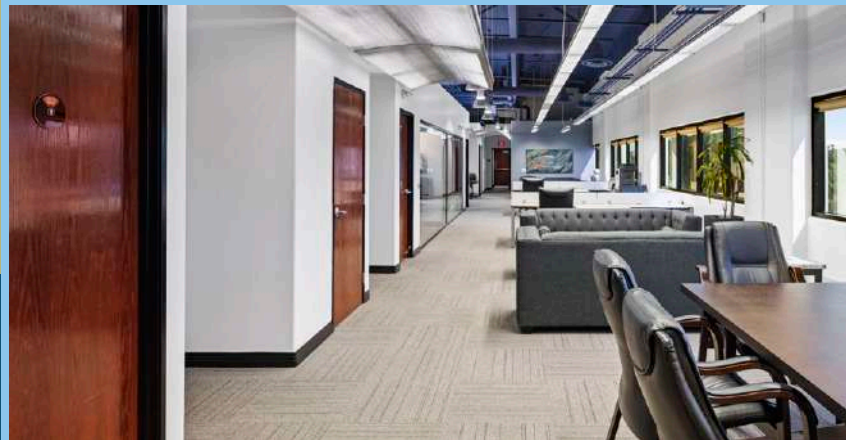
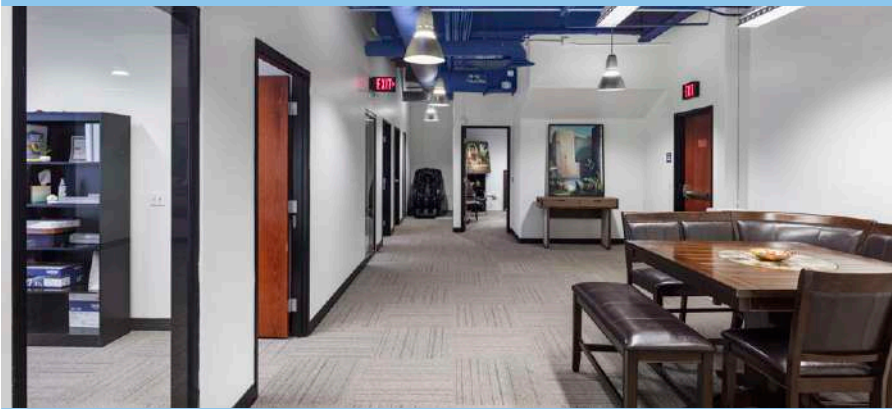
SITE PLAN



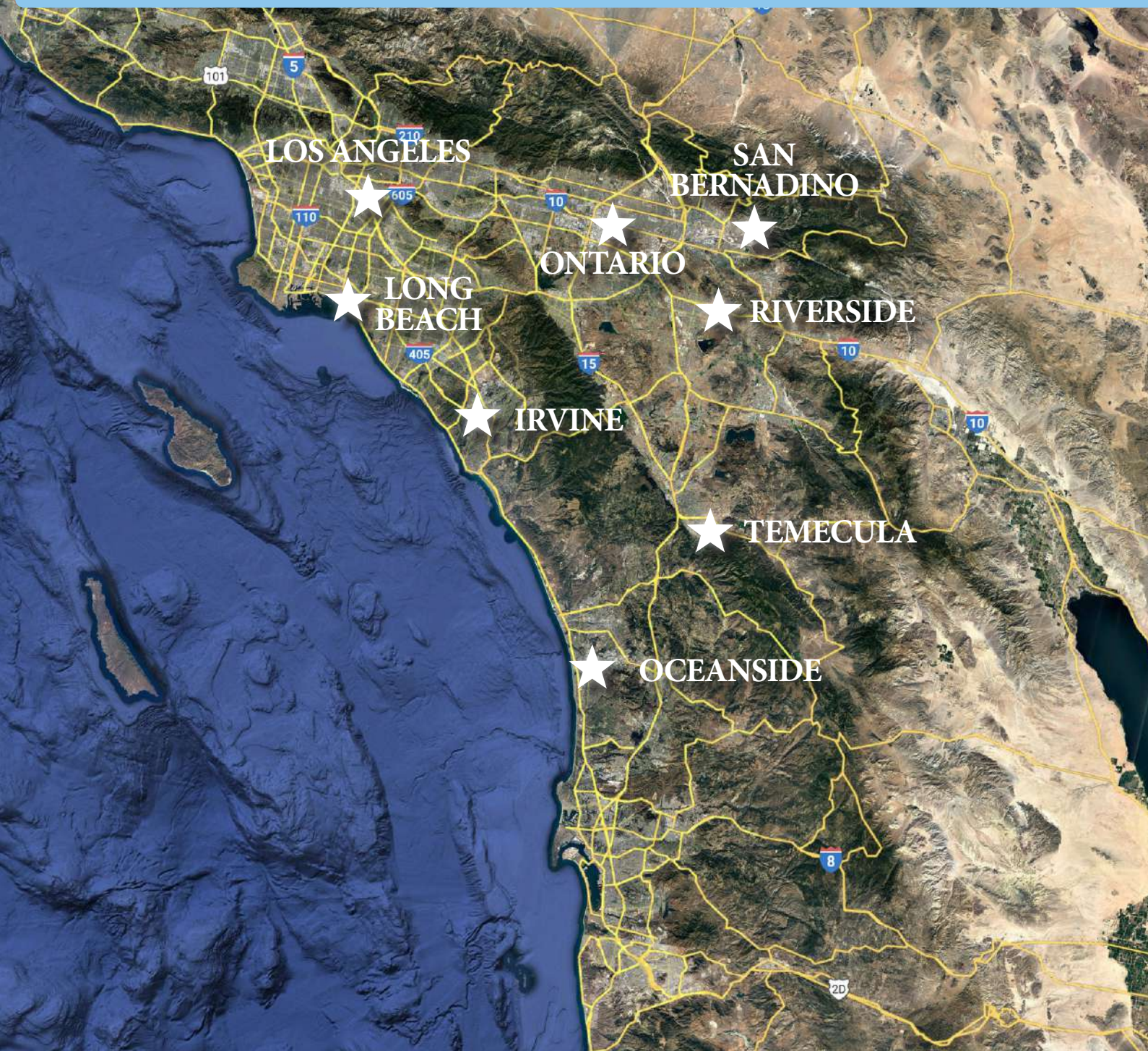
