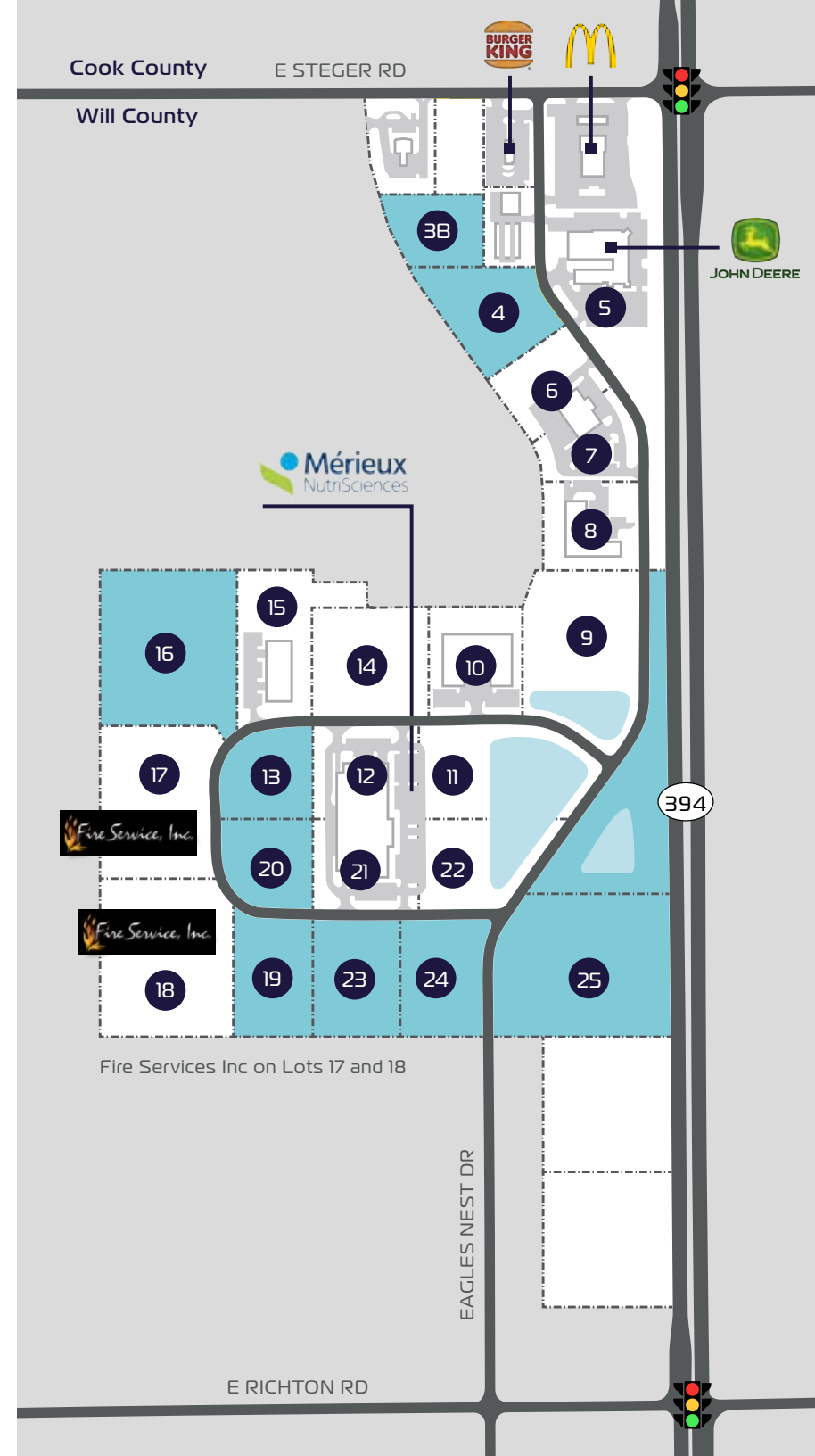
Site Plan Key

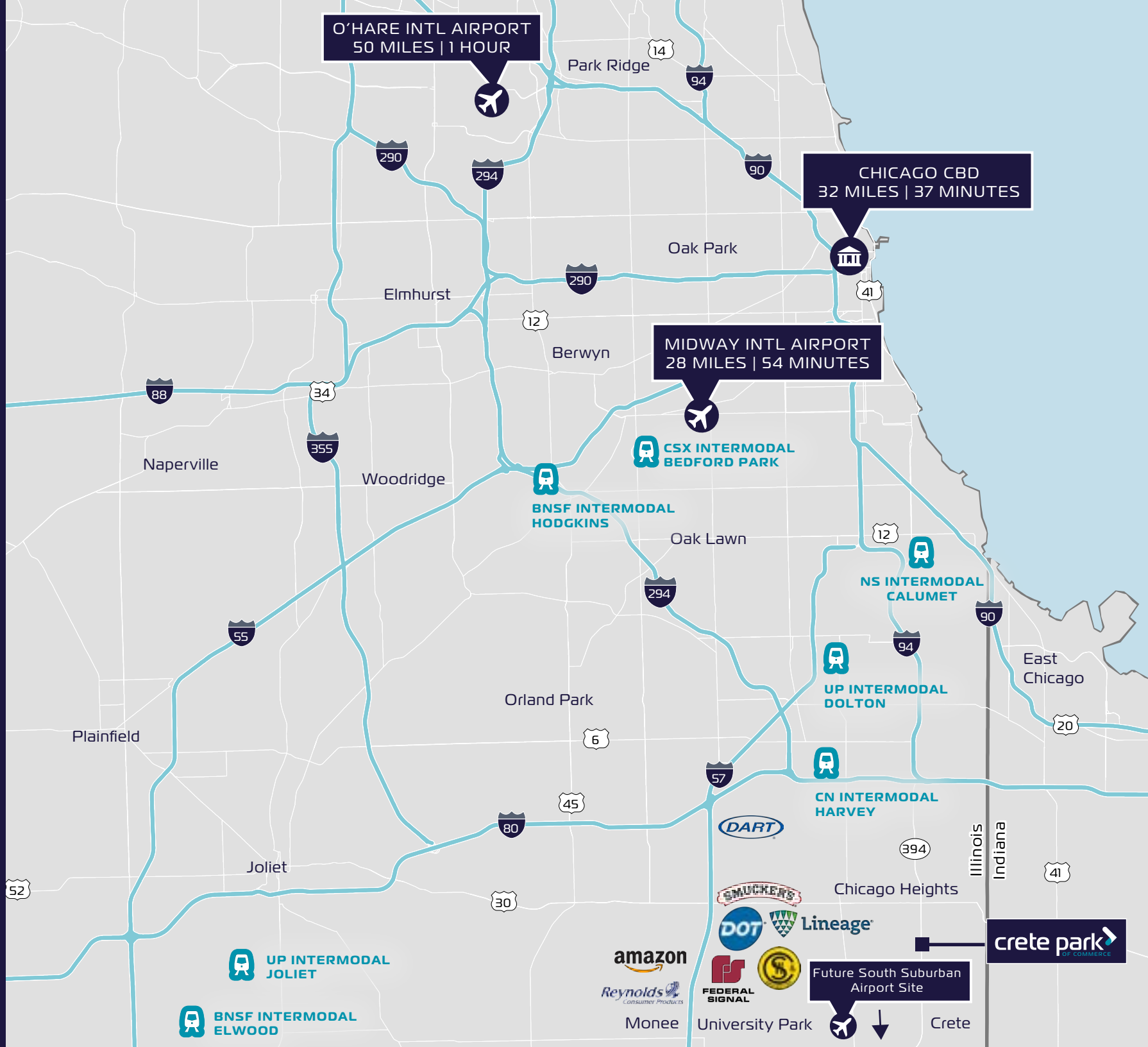
